Pastor & President Letter

Sisters, Brothers, and Friends of Lutheran Church of Hope:

This year we celebrate 59 years of ministry here at LCHope! We have come a long way since those early days in the fall of 1963. Today LCHope is known throughout the Broomfield area and beyond for sharing and transforming of faith, hopes, and lives. As your President and Pastor, we have the vantage point of both leading and seeing ministry happen daily. Real lives are changed in the name of Jesus – by you, the ones who gather here to be fed by God's grace and sent with hope into the world.

Your Board of Trustees and Leadership Teams have been working hard to do amazing things here at Lutheran Church of Hope. You may have experienced these things in such ways as:

Choirs singing and ringing:

• BLAST kids departing and joyfully returning to worship;

Drives for food, coats, diapers, and many more necessities;

Cancer Care and other support groups;

Santa Sacks and Mittens; and

Many more ministries that happen here at LCHope.

We are profoundly grateful for the care and support given by this congregation.

We completed our feasibility study which led to our capital campaign, "Building Hope for the Future." At the time of finalizing this report, our campaign is just shy of \$3,500,000. More importantly as Pastor Scott preached on Commitment Sunday, it is not about the dollars and cents, but the journey along the way – the stories shared, the volunteers who helped, the 24-hour prayer vigil, and the incredible journey we have ahead of us. Stay tuned in the next months as we discern our final project proposal. It will be an exciting 60th anniversary ministry year!

Additionally, we finalized an accredited review of our entire financial ministry by the accounting firm of Capin Crouse, who specializes in church accounting and procedures. A brief summary is included later in this report. Our financial ministry is safe, secure, and robust as we have grown exponentially over these past few years. With next year's Spending Plan Proposal, we are looking to hire a part-time bookkeeper to handle our books. Marlys' job has grown too large, and she needs assistance. LCHope has grown and expects to generously receive well over \$1,000,000. The caring for and safe keeping of your generosity is vitally important to the outcome of ministries here at Lutheran Church of Hope.

With the help of the Financial Management Team, we continue to monitor our monthly reports. In the past fiscal year, there have been some significant increases in utilities and property maintenance. Even with these increases, our spending plan is on track once again for LCHope to finish the year strong and balanced! Ministry leaders have been excellent in using the resources provided to them with wisdom and care. To receive your generosity with better ease, we have switched our online giving providers to PushPay and have added Venmo as an option for giving as well.

As we finalize this report, thanks to the generosity of a member household, a 'new-to-LCHope' digital sign has been purchased and will be installed as soon as permitting will allow. This digital marquee will enable LCHope to communicate events and opportunities for the community to 'come and see' what LCHope is all about – the sharing and transforming of faith, hopes, and lives!

When leading LCHope, we get to work with some talented and gifted fellow staff and elected leaders. They are some of the hardest working ministry leaders the church has to offer. We are so proud to work alongside them. They are indeed a gift to us!

As we close our two years of ministry together as President and Pastor, we are grateful for the time we have had to lead this ministry at a vital time in the church's life. We continue to encounter and address growing and thriving opportunities when we see so many others struggling. We see building hope for the future as a reality today – and for that, we are grateful. Thank you for letting us serve and lead you.

Kenda Meyer our Chancel Choir Director was recognized for 10+ years of music ministry at LCHope.








Michael Kastner was hired as the Bells of Hope handbell choir director in 2022.

What we do well:

We are a community that knows how to take care of our community, be it congregation members or reaching out to those outside our walls. One ministry that we do exceptionally well is funerals. This is not an easy path for survivors to walk and we have become known as a place that takes care of the details.

Just recently we welcomed a family who needed a place to celebrate the life of their dear father. We welcomed them with open arms and made an impression. They had watched services online a few times prior to planning and had decided this was the place to host the celebration. LCHope treated them as they treat everyone, with dignity, respect, reverence and provided the family a place of comfort. The family was BLOWN AWAY. They were unable to say enough good things, and I believe have been attending off and on virtually since.

LCHope really is a place where you can count on support in your darkest hours, and we keep proving it time and time again.

COMMUNICATIONS

This was a year of change, growth and learning for everyone involved in communications at LCHope. Jennifer Powell stepped down to focus on her family. Stephanie Foster and Kate Hayes stepped in as the interim communication team while the congregation created a job description for and searched for a candidate for a new full-time position on staff as "Director of Communications & Membership". In October of 2022 Eli Passage was hired for this new role. He came to LCHope with a background in Christian non-profit communication in web and social media management and live game production which helps him with LCHope's livestream. Eli is grateful to Stephanie Foster, Marlys Dufour, Pastor Scott and others who have taught him day to day responsibilities within his position. He has also learned the values and yearly responsibilities important to the congregation's practice of the Lutheran faith tradition, a denomination that is new to Eli.

It has been about 18 months since our first resident moved into Anchor House and a lot has transpired since then. During that time, we have experienced some operational changes as we continue to learn how to best serve the eight young men and women who call Anchor House home. Since last May, we have successfully transitioned Andrea Margheim-Minnich as house manager for the facility. In April, we hired a consultant to further develop and refine the life coaching programs for the residents.

- We have one resident who has decided to join LCHope and we are grateful for that.
- With leadership from LCHope member Albert Bond, Resident Suppers started this year where LCHope volunteers host and cook dinner for Anchor House residents. These dinners are hosted in the LCHope fellowship hall and are a great opportunity for LCHope congregants to meet. get to know and build relationships with young adults living at Anchor House.
- Thrivent is producing a promotional video about the ministry of Anchor House and how they were a financial partner in the construction of Anchor House. PScott, John Bosio, Andrea Margheim-Minnich and two residents were interviewed and will be featured in the video.

FINANCIAL REVIEW



In late 2021, the LCHope Board of Trustees agreed that it was time for an external, independent assessment of its financial processes and statements. The Board agreed to hire <u>CapinCrouse</u>, a national full-service CPA and consulting firm devoted to serving nonprofit organizations (especially, religious nonprofits), to conduct a financial review.

To start the review, we completed CapinCrouse's initial list of requests (e.g., gathering statements, policies). Then, we addressed their questions and suggested changes. One key change was to adopt the Modified Cash Basis accounting method, instead of GAAP.

CapinCrouse recommended that we do so, and we collectively agreed after weighing the pros and cons. Other key recommendations include migrating to more-modern accounting software (e.g., QuickBooks) and hiring a part-time Bookkeeper.

Upon completing the review, CapinCrouse concluded that there were no substantial issues with our finances or how they were managed. If you are interested in seeing the full report, please contact Marlys in the office.

Make us ready to live the gospel and eager to do your will, so that we may share with all your church in the joys of eternal life, through Jesus Christ, our Savior and Lord. Amen."

RATIONALE AND BACKGROUND INFORMATION

The Annual Ministry Spending Plan for LCHope provides clear visibility into the financial support of our mission tenets: Worship, Discipleship, Reaching Out, and Loving Support. To provide this visibility, a Mission Spending Plan based directly on the Line-Item Spending Plan has been created and is presented in this document. The Mission Spending Plan shows the allocation of direct expenses, salaries, and facility costs to the supported mission tenet ministry.

The Line-Item Spending Plan is available in the church office upon request. The Line-Item Spending Plan is essential for meeting business accounting standards and tracking specific incomes and expenses.

In the Fall of 2022, elected and staff leadership of the congregation discerned the proposed ministry investments for the 2023-2024 ministry year. Their proposals shaped the 'Lutheran Church of Hope: It's What We Do' Annual Mission Appeal that took place in the winter of 2023. This appeal resulted in 141 Partner-in-Mission Commitments for a total of \$673,000. Added to this were forecasted offerings of households who continue to give generously without having submitted a Partner-in-Mission Commitment Card, two significant financial commitments, anticipated unattributable and new offerings, and a \$20,000 investment from past surpluses. These gifts bring the total forecasted Offerings to \$780,350.

There are 77 Partners who increased their commitments, 35 Partners who continued their current level of giving, and 10 Partners who decreased their giving. Fifteen new Partner-in-Mission Commitments were received. There were nine giving households that either were deceased or transitioned out of LCHope over the past year as well. Along with some various income and gifts in kind for facility use, the Board of Trustees is presenting to the congregation for adoption a proposed Spending Plan showing a total investment of \$780,350.

We would like to thank you, the members of LCHope for your generous giving – for truly providing resources so that we may 'share and transform faith, hopes, and lives.'

Highlights include the following:

Offerings and Income are increased by 2% to \$780,349.

- 141 Partner-in-Mission Commitments for a total of \$673,000
 - Includes offerings forecasted based on previous giving records from 27 households who did not submit a Partner-in-Mission Card
- Financial Ministry Commitment of \$50,000
- \$7,500 in loose unattributable cash offerings
- \$7,524 in General Fund Special Appeals throughout the year (i.e., Giving Tuesday and/or End of Ministry Year Giving)
- New Giving in Faith of \$21,000...this represents new giving from visitors and those who come to part of our community over the next year
- An investment from past surpluses of \$20,000
 Other Income of \$1,325 is forecasted through use-in-kind gifts and bank account interest



Reflection of the Lead Pastor - Pastor Scott McAnally:

Pastor Scott reflected on the phrase "There's something about Hope," recalling renewing, recharging, refreshing, never being bored. He expressed special thanks to the LCHope staff, elected leaders and dedicated volunteers for their continued leadership, support, and guidance during the past year. He noted that there will be a search for a new communications director and a director for Bells of Hope.

He also expressed thanks to Jen for her companionship in his call and to his family and to the congregation for nurturing them.

<u>Video Presentation:</u> Members watched a video celebrating the past year of LCHope developed by outgoing communications minister Jennifer Powell.

Adoption of Mission Spending Plan

President Vialpando referred to the printed Annual Report for background, rationale and major points for the proposed 2022-2033 Ministry Spending Plan printed on pages 16-19 of the Annual Report. He expressed thanks to the congregation for generous giving and encouragement during the past year. He noted that proposed offerings and income are increased 12%, moving to a total spending plan of \$764,467. President Vialpando expressed special thanks to Dan Hartman, treasurer, and Beth Bosio, financial secretary, the Financial Management Team, and the Mission Advancement Team. Filling in as secretary for the meeting, President-Elect Brenda Peterson announced that there were 93 voting members present.

President Vialpando announced that in consideration of today's resolution, voting would be by paper ballot. Kate Hayes, Bob Ambrosio, and Bob Moody were announced as tellers for counting the ballots.

Concerning the Capital Campaign for Lutheran Church of Hope

WHEREAS, the Board of Trustees of Lutheran Church of Hope (LCHope) appointed the Capital Campaign Thinking Group in February of 2021 to research, consult, and have conversations with church officials and non-profit development fundraising organizations to learn about raising capital resources to fund a potential building project at LCHope; and

WHEREAS, the Capital Campaign Thinking Group held conversations with five organizations that are well known in church capital fundraising circles around their experience, process, and success rate with raising funds for church capital building projects; and

WHEREAS, the Capital Campaign Thinking Group requested specific proposals from two organizations for formal consideration of possible partnership in raising funds for a potential building project; and

WHEREAS, Walsh and Associates are recommended because of their faith-based campaign approach, focus on church fund raising versus corporate fund raising, experience with churches approximately the size of LCHope, onsite more days than others, and

WHEREAS, the Feasibility Study Report dated October 23, 2022, from Walsh and Associates recommends Lutheran Church of Hope to commence a campaign immediately with a minimum goal of \$2,500,000, a challenge goal of \$5,000,000 and an ultimate goal of \$7,000,000; therefore

Be It Resolved, that the Board of Trustees recommends that the Congregation of Lutheran Church of Hope contract with Walsh and Associates to complete a capital campaign based on the proposed conceptual building project approved by the congregation on May 22, 2022; and,

Be It Further Resolved, that the cost of the campaign be no more than \$100,000 including consulting fee, consultant travel, staff resources, as well as campaign related marketing and events, be paid by already pledged special gifts on behalf of LCHope; and,

Be It Further Resolved, that the capital campaign begin forthwith with planning and organizing steps, with a late winter and spring campaign concluding with a time of celebration the weekend of our annual meeting on May 21, 2023; and,

Be It Further Resolved, that the Congregation of Lutheran Church of Hope offer its gratitude and continuing affirmation to the Capital Campaign Thinking Group including chair Bill Thieme, and members Gerry Herbst, Anna Jordan-Helser, Joe Kern, Holly Pederson, John Vialpando, and Pastor Scott McAnally (ex officio) for their work on behalf of the Congregation of Lutheran Church of Hope.

Following an adopted motion to call the question, ballots were distributed with the stipulation that voting was restricted to members aged 18 and above.

Regarding Lutheran Church of Hope Resolution No. 2022-03, concerning the Capital Campaign for Lutheran Church of Hope, following is the official vote count:

Legal ballots cast = 93

For = 82 Opposed = 7 Abstain = 4

President Vialpando declared that the resolution was adopted.


Pastor Scott McAnally led the congregation in closing prayer.

BUILDING TEAM & ORGAN TASK FORCE REPORT



After a busy spring of 2022 developing the proposed conceptual design for Building Hope for the Future, the building team shifted focus as the feasibility study and capital campaign began. However, the Building Team kept up its work with some very important background and foundation work for any building project. Initial courtesy conversations with the City and County of Broomfield have indicated that there are no major objections to the conceptual project. Last fall and winter the important soils study was completed by A.G. Wassenaar Incorporated in addition to the survey that was completed this winter and spring by Civil Arts Surveying. With the pledging of the capital campaign wrapping up, the design and development phase of the project will continue with haste, enabling LCHope to take the next step in obtaining more accurate construction bids in addition to value-engineering, congregation-wide labor, and partnerships that may exist with congregation member's professional vocations. Final Organ Report

The Organ Task Force began the year with news that Reuter Pipe Organs was ceasing operations and coordinating the LCHope organ's move from Reuter's storage facility that had been sold to Schantz Organ Company's storage facility in Ohio. Shortages in the craftsman labor market along with materials costs and inflation have severely hit the pipe organ industry in particular. The Task Force spent time over the winter months researching reputable organ builders that have experience renewing, re-designing, and installing Reuter Pipe Organs. Several informal conversations led to three formal 'teams conversations' with organ builders Buzard, Schantz, and Berghaus. A Request for Proposal (RFP) has been developed and sent to each builder with responses due back May 19th. Each company will consult with our church architects IDG, as part of their proposal that will include conceptual facades, updated stop lists, any other infrastructure replacements or renovations, as well as possible long-term full organ build-outs that will complement our conceptual worship space. It will be a busy late spring and summer as the Task Force reviews the RFP's and makes a recommendation of a builder moving forward. Serving on the Organ Task Force are: Patricia Kennedy and Judy Vialpando, co-chairs; Charlie Freitag, vice-chair; Sue Lyon, Kate Hayes, Karen Kuhlmann, Patricia Thomas, Anna Jordan-Helser, Beth De Boer, Sue McKnight, Kenda Meyer, Michael Kastner, and PScott.

As the training progressed, conversations between people validated the concerns and doubts that came up. They also provided a platform for others to share their reasons for joining, and different perspectives on what the fulfillment of the campaign could mean for all the ministries here at LCHope.

As the initial stages of gift gathering went into full swing, it was incredible and heart-warming to listen to the stories they had to tell. So many gift gatherers came back with stories of just enjoying the time they had conversing over coffee. They met new friends, and got to connect better with friends they already knew. A couple of gift gatherers met folks and found connections with extended family members in different states. They discovered skills and talents in people they had no idea existed. One had a personal epiphany about the need for expansion when there were not enough rooms for different groups to meet in after church. The statement that warms my heart the most is the one almost every volunteer has shared with me: "I just had such a good time visiting with people and getting to know them better!" We're not just Building Hope for the Future – we're building community within and outside of a place called Lutheran Church of Hope.
